

**NORTH STRABANE TOWNSHIP
GENERAL RULES AND REGULATIONS
APPLICANTS - 2008**

Person(s) or groups desiring the Park Pavilions/Facility will be granted the privilege providing all rules and regulations are adhered to. Permission may be revoked at any time for failure to comply. Permits will be granted on a "First Come" basis to the North Strabane Township Residents and Businesses. Beginning the 1st working day of February: thereafter, beginning the 1st working day of March applications will be accepted from the general public. Permit and deposit fees must be paid for at the time of reservation.

Priority consideration regarding Park scheduling will be given to the Township and residents, i.e. Community Day, and other special activities deemed necessary. The school district has first reservation preference for athletic games, practice, contests, or exhibitions, and recreation programs.

All person(s) or group(s) reserving a Park facility MUST obtain & possess a North Strabane Township Park Permit when occupying the Park facility. All person(s) or group(s) must sign a waiver releasing the Township of all liabilities that may occur.

Any League or Team authorized by the Parks and Recreation Board to use the Softball Field will be given 1st priority. Ball Field may not be available during your time of pavilion rental, unless special arrangements have been made with the Parks & Recreation Board.

Quail Acres Pavilion accommodates approximately 100 people, Froman's Mill about 40 people and Beck's Mill about 20 people.

1. Any activity must be conducted according to law and conform to accepted good standards of conduct.
2. Beverages will be permitted in designated areas. No glass bottles or beverage trucks will be permitted in the Park. No alcohol will be permitted at the Ball field/Soccer Field/Basketball Court.
3. No person shall either by word or act, indulge in any disorderly or indecent conduct, or disturb the peace of the community.
4. No motorized vehicles are permitted on the track.
5. FIRES are limited to those used for cooking, but only in designated receptacles, and must be extinguished by the responsible party.
6. PROPERTY OF TOWNSHIP: No person shall injure or deface any part of the park nor remove or destroy any natural features.
7. PARK HOURS shall be from dawn until dusk. Lighted softball field shall be 11:00PM. Unless special permission is granted from the Parks Board these hours will be enforced.

8. ANIMALS: No animals are permitted in the Park.
9. Horseshoe pitching in horseshoe courts only.
10. **PERMIT FEES FOR PAVILIONS ARE NON-REFUNDABLE.** Security Deposits are refundable after the event, providing the persons or groups adhered to the guidelines.
11. PARKING: Please park in designated areas or on pavement, excluding Track/Basketball Court.
12. CLEAN UP/DAMAGE/SECURITY: If necessary, charges will be assessed for clean up or repair exceeding the routine. Please make every effort to keep the area clean, safe and fully restored after your use, so that others will have the same enjoyment at the Park.
13. TRASH: At all Park facilities, we make every effort to provide reasonable containers to accommodate the needs of most groups. If, however, your group generates more trash than can be safely or neatly stored, please be prepared to bag and haul to a dumpster. (Located at the end of the parking lot or by the Maintenance Building). Littering is prohibited.
14. STRUCTURES: Additional structures must be approved prior to the event by the Parks & Recreation Department.
15. No person shall shoot or carry firearms
16. SCOOTERS, BICYCLES AND ROLLER BLADES – NO scooters, bicycles or Roller Blades are permitted on the basketball court.

SOFTBALL FIELD	
Seasonal Rates:	\$ 75.00 per non-lighted time-slot. \$225.00 per lighted time slot.

1. Seasons: Spring Season runs from early spring through August. Fall Season begins after Labor Day of that given year.
2. Weekend rates are \$50.00 per day. A minimal fee for usage of lights may be assessed accordingly.
3. A deposit of \$25.00 for keys to the light box is required. This fee will be refunded when keys are returned to the Township.
4. Currently, time-slots are set up in 1 ½ - 2 hour increments: Monday through Friday. Time-slot increment(s) may change due to the demand of the field(s).
5. **SUBJECT TO BUMPING**: During the normal season, if a group requests the field to host a tournament, all normal time-slots are subject to be bumped. Adequate time for re-scheduling bumped time-slots will be required.
6. BALLFIELDS: Please use with extreme caution during wet conditions or be prepared to be responsible for serious turf or infield damage.
7. CANCELLATION OF FIELD RESERVATION: In case of a cancellation, the party shall notify the Township office. If a Special use Field facility reservation is cancelled with at least 72 hours notice prior to the activity a full refund is available. If the event is cancelled less than 72 hours, the deposit is refunded and not the rental fee. Rain dates may be re-scheduled as space permits.

MULTI PURPOSE FIELD

Seasonal Rates: \$150.00 per Season . Spring Season is normally April through June. Fall Season generally begins in September.

The allotted times normally consists of 2 evenings and 1 weekend day.

CANCELLATION OF FIELD RESERVATION: In case of a cancellation, the party shall notify the Township. If a Special use facility reservation is cancelled with at least 72 hours notice prior to the activity a full refund is available. If the event is cancelled less than 72 hours prior to the event, the deposit is refunded and not the rental fee. Rain dates may be re-scheduled as space permits.

BASKETBALL COURT

No fees are applicable at this time.
